

TERMS GOVERNING THE REPRODUCTION AND USE OF THE NATIONAL WOMAN’S PARTY COLLECTION

The National Woman’s Party and the Sewall-Belmont House and Museum (collectively, the “NWP”) encourage the use of the organization’s collection of historic documents, including strategy documents, newspapers, political cartoons, scrapbooks, organizational records, textiles, artifacts, and photographs (collectively, the “Collection”) by the public for scholarly, educational, and non-profit purposes.

The NWP allows members of the public to request copies of historic documents in the Collection through this web site, NWPcollection.org (the “Site”). A duplicate copy or, in some cases, a restored copy, of a historic document displayed on this site (the “Image”) may be obtained from the NWP, subject to the following terms and conditions (the “Terms & Conditions”).

The content on this site, including text, Images and other images, audio and video clips, is the property of the NWP, the Museum, and/or certain third parties, and may be protected by copyright and other applicable laws. The NWP expressly prohibits the copying of the content of this Site, except as permitted by law or as otherwise permitted by the NWP as set forth below.

A. REQUESTING AN IMAGE

1. You may request an Image by completing and submitting an *[Image Duplication and Permission Request Form]* (“Duplication and Permission Form”), along with a payment for the applicable *[Duplication and Permission Fees]*. The NWP may ask you to provide additional information or clarify the information you have provided on your request form to assist it in making an informed decision as to whether to grant your request. Whether the NWP approves your request is subject to the NWP’s sole discretion. If you have questions about what information to include in your request form, please contact the Collections Manager at (202) 546.1210, extension 11.

2. The content on this Site, including the Images, may be protected by copyright and such rights may be owned by the NWP or third parties (collectively, “Third-Party Owners”). The NWP will not provide you with an Image if the NWP (a) does not hold the copyright in the Image, (b) lacks the appropriate authorization from the Relevant Third Party Owner, or (c) the Image is not in the public domain. If you would like to obtain such an Image, the NWP may provide reasonable assistance to help you locate the appropriate Third-Party Owner(s), from whom you may separately arrange to obtain such Image. Notwithstanding any assistance that the NWP may provide to you, you are solely responsible for obtaining from Third-Party Owners any necessary permissions to use Images the rights to which are not held by the NWP.

3. Following review of your request, the NWP will send you a letter indicating whether it will provide you with the requested Image and approve your proposed use. If approved, the NWP will include the requested Image(s) with its letter or, if denied, it will refund all fees submitted with your request form.

B. DUPLICATION AND USAGE FEES

1. In connection with your Duplication and Permission Form, you may be required to pay [*duplication and usage fees*], depending upon the proposed use of such Image. All such fees help support the NWP and its Collection and are nonrefundable [after your request is granted.] Upon prior notice to you, we may charge additional fees for restoration requests, complicated orders, or for excess staff time, at the sole discretion of the NWP. All such additional fees will be invoiced separately.

2. Certain fees may be waived or reduced depending upon the nature of your proposed use of an Image, at the sole discretion of the NWP. The NWP will advise you of any such waiver or fee reduction and refund any such fees to you accordingly.

C. SCOPE OF PERMITTED USE OF IMAGES

1. Your right to use any Image provided to you by the NWP shall be non-exclusive, non-transferable, and limited as set forth in the approved Duplication and Permission Form and these Terms & Conditions. All rights to use of Images granted by the NWP shall apply only to the United States, unless otherwise indicated by the NWP. Possession of an Image does not constitute permission to use such Image in any manner whatsoever, unless approved by the NWP pursuant to these Terms & Conditions.

2. The rights granted in connection with an approved Duplication and Permission Form do not include the right to download any Image from this web site or any other source.

3. Permission to use an Image provided by the NWP does not imply that the NWP endorses the manner of usage, the accuracy of the interpretation of the Image, the accuracy of the text which accompanies the Image, or any context in which the Image appears.

4. Your right to use the Image is limited to the purpose specified in the approved Duplication and Permission Form. Any further use of the Image requires the submission of a separate request and payment of additional fees, if applicable. Such further prohibited uses include, but are not limited to, modifying, displaying, making performances of, distributing, having Images serve as the basis for any derivative works of any Images, quoting extensively from Image for publication, using Images in a different media or in a different format (including new editions of books or publications); use of such Images in materials promoting, advertising or marketing an authorized use; or granting rights to use the Image to any other party; making an Image electronically available to any other party (including storing any Image on a public computer server or network accessible by any person other than you or sharing passwords to any protected database containing any Image).

5. Under no circumstances may you:

- (a) Use or register any Image as a logo, trademark, service mark or other similar designation for you or a business or organization;

- (b) Use any Image, including any element or individual's name or likeness in such Image, in any manner that suggests endorsement of or association with any product, service or organization; or
- (c) Use, reproduce, publicly display, or distribute any Image in an immoral, obscene or scandalous manner.

6. Except as permitted under these Terms & Conditions, as authorized in writing by the NWP, Images may not be used for any commercial purpose. Except as provided in these Terms & Conditions, nothing contained herein shall be construed as granting any license or right to any copyright, trademark, or other intellectual property right in connection with any Images or any content on this web site.

7. As a condition of the Image use authorization granted to you by the NWP, and unless otherwise agreed by the NWP, you shall submit one copy (in either digital or analog format, as appropriate) of any published material incorporating an Image provided by the NWP within 90 days of first publication of such materials at no cost to the NWP. In the sole discretion of the NWP, such materials may be held in the Florence Bayard Hilles Library of the Sewall-Belmont House and Museum for the purposes of education and research.

D. CREDIT AND COPYRIGHT NOTICE REQUIREMENTS

1. For every use of an Image, you must, unless otherwise specified by the NWP, give credit to the NWP as the source of the Image by using the following credit line: **“Courtesy of the National Woman’s Party Collection, The Sewall-Belmont House and Museum, Washington, D.C.”** Credit lines must appear on or near each Image used, or on a separate page that indicates the page number and placement of the Image, in a manner accessible to the public.

2. You shall not intentionally modify, obscure, or remove any copyright notices or other attribution or metadata in or associated with any Image. If no such notice, attribution or metadata is included in or associated with such Image, you shall display the following notice directly under each Image: **“Copyright 200[5] National Woman’s Party [or the name of a Third-Party Owner, if applicable]. All Rights Reserved.”**

E. TERM AND TERMINATION

1. Your rights to use any Image under these Terms & Conditions shall expire upon the completion of the specific project or time period set forth in your approved Duplication and Permission Form, or as otherwise communicated to you in writing by the NWP. Further, any failure to comply with any of these Terms & Conditions by you shall automatically terminate your rights to use the Image.

2. Upon termination or expiration of your rights to use any Image for any reason, you shall cease all use of such Image and (a) promptly delete, erase or otherwise destroy any and all electronic copies of such Image in your possession or control; and (b) promptly return any and all hard copies of such Image in your possession or control. .

F. DISCLAIMER OF WARRANTIES, LIMITATION ON LIABILITY AND INDEMNIFICATION

1. All Images obtained through the NWP are provided to you on an “as is” basis and the NWP and any Third-Party Owners of any Images expressly disclaim to the fullest extent of the law any and all warranties, or representations of any kind (express, implied, oral, or written) relating to the Images or the Collection, including without limitation, any and all implied warranties of quality, merchantability, fitness for a particular purpose, and/or non-infringement. In addition, the NWP does not represent or warrant that the information on this web site is accurate, complete or current.

2. In no event shall either the NWP or any Third-Party Owner be liable for any indirect, special, incidental, punitive, or consequential damages, including, without limitation, loss of profits, loss of data, loss of business or other loss arising out of or resulting from any use by you of any Image pursuant to these terms and conditions, even if such parties have been advised of the possibility of such damages.

3. You agree to indemnify, defend, and hold harmless the NWP, any Third-Party Owner, their affiliates and their respective agents, employees, officers, directors, and legal representatives from all costs, damages, attorneys’ fees, and other expenses arising out of any use by you of any Image that exceeds or violates the approved uses set forth in your Duplication and Permission Form and these Terms & Conditions.

4. This Site may provide links to third-party web sites. Such linked sites are not under the control of the NWP and the NWP is not responsible for the content or practices of any such linked web sites. These links are provided as a convenience to you only and shall not be construed as an endorsement of, sponsorship of, or affiliation with the linked web site by the NWP.

G. GOVERNING LAW AND JURISDICTION

These Terms & Conditions shall be interpreted and construed according to, and governed by, the laws of the [the District of Columbia], without regard to any conflict of law provision. Any controversy or claim arising out of or relating to these Terms & Conditions or the breach thereof shall be subject to the exclusive jurisdiction of the courts in the [District of Columbia].

H. WAIVER OR INVALIDITY OF ANY PROVISION

Waiver of any provision in these Terms & Conditions shall not be deemed to be a waiver of any other provision herein, nor shall waiver of any breach of these Terms & Conditions be construed as a continuing waiver of other breaches of the same or other provisions of these Terms & Conditions. If any of these Terms & Conditions are held to be invalid, illegal, unenforceable, or in conflict with the law of any jurisdiction, the validity, legality, and enforceability of the remaining provisions shall not in any way be affected or impaired thereby.

I. MODIFICATION OF TERMS AND CONDITIONS

The NWP reserves the right to change these Terms & Conditions from time to time without notice. You agree to periodically review these Terms & Conditions and to be bound by any such future modifications, as posted on this web site.

J. INTEGRATION

These Terms & Conditions and any approved Duplication and Permission Forms shall constitute the entire agreement between you and the NWP pertaining to your use of any Images and supersede all prior and contemporaneous agreements, representations, and understandings between you and the NWP.
